### SECTION 4. FIRST AID MEASURES

**Eyes:** Immediately flush with water for 15 minutes. Obtain medical attention if irritation occurs.

### SECTION 6. ACCIDENTAL RELEASE MEASURES

**Containment/Clean up:** Collect for disposal. Clean up remaining materials from spill with suitable absorbent. Clean area as appropriate since some silicone material, even in small quantities, may present a slip hazard. Final cleaning may require steam, solvents or detergents.

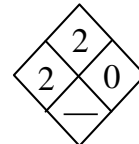
